Cllr Griffin updated his report; his response to an article by Dorset Councillor Beddow in The Purbeck Gazette, encouraging residents to consider becoming a local councilor, was published, and he received a personal reply from Cllr Beddow.

Dorset Councillor Starr attended a meeting promoting enterprises in small towns, with Bridport as the example. It was commented that Upton is very different, both geographically and economically to Bridport.

**Upton Together:** The group continues to support the community by delivering prescriptions. Cllr McKell reported the popular and successful Great Easter Egg Hunt will be held again on Easter Sunday (31 March 2024), at Upton Recreation Ground between 10am and 12 noon. All Councillors are invited to come along and help.

Cllr McKell also updated Upton Together are progressing the opening of their own bank account.

**Upton In Bloom:** UiB are planning a Dementia Friendly garden at Upton Manor Care Home. The Lavender Walk bed at the rear of the Clock Tower, maintained by UiB, will be dedicated to the memory of the late Martyn Chase.

# 412/23 ITEMS OF REPORT (INCLUDING PUBLICITY OPPORTUNITIES) AND MATTERS FOR FUTURE AGENDAS:

- 1. Cllr Burns raised the issue of Lytchett Minster and Upton being 'on the edge' of the Dorset Council boundary, neighbouring Hamworthy, also 'on the edge' of the BCP boundary. Attempts to liaise with Hamworthy Councillors regarding shared issues, has not previously been successful. The three Councillors serving Hamworthy ward; Cllr Julie Bagwell, Cllr Brian Hitchcock and Cllr Peter Cooper, will be contacted proposing a meeting with LMUTC to discuss shared issues and concerns, with a view to working jointly to resolve concerns. (eg: ASB, fly tipping etc)
- Cllr Squires reported the £16k grant application re: Redwood Road Play Park renovation, to the Dorset Council Capital Leverage fund was unsuccessful. He will continue to explore other funding avenues. Cllr White reminded members of Cllr Gabriel's role as Funding Champion and the importance of ensuring unified information on all LMUTC applications.
- 3. Community Picnic: Cllr Griffin updated members on progress for Saturday 8 June 2024 1pm to 5pm on Upton Rec. Singers, 'The Land Army Girls' and 'Heather Williams', an Inflatable Assault Course, Coffee Kart and Tractor have all confirmed. Children's Fancy dress competition will be 1940's themed. Face Painting, Ice cream van/s, Fish & Chip van, Fire engine, Police Vehicles, Urban Bike Display, and 'Krazy Kev' children's entertainer have all to confirm. Other possibilities are Cadets Marching Band, Church musicians, Ukele band, LM school musicians, classic vehicles. Cllr Pipe will liaise with Royal Signals Blandford and Royal Marines, Hamworthy regarding a WWII military presence. First Aid provision will be confirmed. Cllr Griffin asked all Councillors to support this event with any help as the Officers of the Council may not be present on the day.
- 4. A letter from a resident neighbouring Upton Recreation Ground wrote to report assorted ASB issues (vehicles 'do-nutting' in the car park, smashed alcohol bottles, evidence of drug use, general noise and disturbance etc) suggesting a Public Spaces Protection Order be applied for. This will be included as an item on the Agenda of the next Amenities meeting on 12 March 2024.
