#### 477/16 CLERK'S REPORT:

### 478/16 CORRESPONDENCE:

- a) Information on the SHLAA sites consultation was received from PDC with a request for comments to be submitted by 3 May 2017. #### 479/16 TO RECEIVE AN UPDATE ON THE MEETING WITH LYMPWATCH:

Several members attended a meeting with Lympwatch on Monday 10 April 2017 and gave a brief report. Concern was expressed that additional development in the area would exacerbate the existing flooding issues and a hydrogeological survey of the area is required. The land that could potentially be developed is the most important area of green belt in Purbeck. Cllr Burns was unable to attend on the 10<sup>th</sup> but will have a private meeting with Lympwatch representatives and District Cllr Pipe.
