Housing 'Preferred Options'

As you are aware, the main topic for debate was the Preferred Options report to Council. After the PRAG [Partial Revue Advisory Group] met at Purbeck School to debate and discuss the "Preferred Options" for housing numbers & sites, the results were discussed & members of the public [our very own Lympwatch included] made themselves heard on the various options & sites. The good news was that the "alternative" site proposed by Cllr Bill Pipe at the PRAG meeting and supported by Cllr Drane and other district councillors has now been officially included in the consultation process. No members of the public decided to speak for, or against the additional 100 homes proposed for the second part of the Policeman's Lane development.
