

The fees, payments and sums set out below apply when the person to be interred or in respect of whom the right was granted is, or immediately before his death was, an inhabitant of the town of Lytchett Minster and Upton, or in the case of a stillborn child, where the parents (or one of them) are, or at the time of the interment were, such residents.

**PART 3  
MONUMENTS, GRAVESTONES, TABLETS AND  
MONUMENTAL INSCRIPTIONS**

For the right to erect or place on a grave or vault in respect of which the exclusive right of burial has been granted-

(i)	a headstone not exceeding 2’ x 1’6” and 3 ft in height ... ..	<b>£113.42</b>
(ii)	a cremation tablet not exceeding 2’ x 2’ x 8” (only available in old cemetery) ... ..	<b>£113.42</b>
(iii)	headstone for cremation plots not exceeding 2’ x 1’ forward 1’8” in height ... ..	<b>£113.42</b>

**Infants** – headstone not exceeding 2’ x 1’ forward and 1’8” in height ... .. **£0\***

The fees indicated for the various headstones of this Part include the first inscription. For each inscription after the first ... .. **£27.70**

The fee for replacing a headstone will be half that of the fee charged for installing a headstone.

Double fees apply to non-residents for all the above services.
