131/20 CLERKS REPORT:

- a. Valuation Report Regarding Land at Hibbs Close and its Potential Disposal. This is still moving forward.
- b. Minute 123/18 To discuss the renewal of the lease of the Recreation Ground. Cllr Burns continues to liaise with the solicitors in relation to CIO details. A meeting of the Turbary Trustees is planned to discuss the restrictions in place in the original lease.

We have been asked by the Adams Practice Manager to get together a team to marshall for 3 days at the ferry terminal. The 12 bodies required have all been informed and the date and times will be 11th, 12th and 13th January. It is hoped that 1500 will be administered during this period bearing in mind that after each jab has been given there is a 15 minute observation period before they can clear the site.

Foodbank

We have acquired some racking so that the food can be spread out and displayed, so we know exactly what we've got and how much. If any councillor knows how we can obtain some of this then can they please contact the helpline. The reason for the sudden urgency is that we have been inundated with food from 2 other foodbanks in the area as well as the food collection boxes in the Co-op and Spar.

Face Masks

Zoe Pipe made 1278 in total that she hopes will be the last the school require. We paid the final payment last week, that is the total of £200 as approved by the panel. I will ask Zoe if she could get some feedback from the school for our log.

Docks Vaccination Update

Over 50 people have come forward to cover the additional dates this week. The format is very simple and we have had nothing but praise and goodwill from the people receiving their jab, so much so that 1 gentleman went straight home and sent a letter to the Echo which was printed in Saturdays edition.

Cllr Wilson reported that £150 had been raised by crowdfunding and another funding source will be followed up.

Proposed TROs are planned for various roads Upton including Pony Drive, Sea View Road, Purbeck Close and Dorchester Road. The reinstatement of the white line along Dorchester Road, Lytchett Minster is not included at this time although it was supported by the Highways Officer.

Planning – Cllr Burns

There are 2 planning applications currently awaiting comments. Dorset Council are starting consultation on the Local Plan from 19 January – 15 March 2021 and members were asked to scutinise and comment.

143/20 REPRESENTATIVES REPORTS/DORSET COUNTY COUNCIL MATTERS:

Report by Cllr A Brenton – Dorset Council

Work continues in Dorset dealing with Coronovirus pandemic. The County is at its worst position so far with DC councillors get a weekly update from Public Health Dorset most Fridays shortly before the figures are released to the public.

Elderly residents are being called for vaccination to the Purbeck Hub (Wareham hospital) or the BIC (Bournemouth) There are at present plenty of volunteer helpers and injectors at Wareham but more may be needed in the long term as this will go on for some time. The holdups are mainly to do with handling the vaccine.

There have been active Covid clusters in Swanage Broadstone and Dorchester (Poundbury) but no where is safe. This wave is affecting and hospitalising more people in their 40-50s even if it is not killing them.

Dorset in cooperation with Citizens Advice bureau have put out several news releases under **Reaching Out. There is** help with non-working because of isolation and with Utility bills this winter.

The Dorset Climate Strategy consultation is open until 20th January, uptake has not been as good as hoped probably because of the bulky consultation. There are only a few hard copies available in libraries which have to be booked in advance. And isolated after return. However the officers are committed to linking every future decision to the effect on Climate change and Ecological impact.

The Dorset Local Plan is prepared for public release and the consultation will be out shortly and open for feed back until March. It is a long and bulky document and needs much concentration. Probably need 2-3 meetings to discuss aspects of it.

143/20 REPRESENTATIVES REPORTS/DORSET COUNTY COUNCIL MATTERS:(Cont)

As councillors we attend many meetings online and there has been some concentration on cyber security and preventing ransomware. One of our residents business has lost access to all past accounts and files, and is looking to replace their whole computer system and servers at great cost and may have to retire early losing 3 jobs.. This is despite having an 'up to date' antivirus software system. There has been a considerable increase in cyber crime as well and email scam crime lately.

Littering along roads and flytipping is an increasing problem and although individuals can pick up litter on their private exercise walks, an organised 'litter pick' may encourage social gatherings and is discouraged at this time.

East Planning Committee meets monthly – there have been no committee decisions on Upton applications lately they have all be delegated recently. If there are any that the Council wishes to be referred please contact me promptly.

I have been asked if Upton can think of a site for a community fridge. It would have to be available for long hours regularly, be accessible in a public building but private so people could access is discreetly. Any suggestions welcomed. We hope to put together a presentation which will introduce the idea more widely.

Last week East Borough Housing Association held a Zoom meeting to discuss with residents the idea of using land at junction of Dacombe Drive and Brushwood as a sit e for up to 4 affordable housing units. This was not well received as this space:- is well used as open play space, is wet, Car parking is an issue and there may be a covenant which prohibits building there.

After long discussion even the suggestion of two small dwellings was rejected on parking and congestion grounds. It was suggested the Town Council could put in a area of end on parking which would only reduce the open space slightly and make parking more efficient.

The green space running through the houses from Brushwood corner to the open square at the bottom of the Drive was suggested as possible area for increased planting to increase biodiversity and wildlife interest . (as part of Uptons Green Agenda) . It would need some input from Upton Council and possibly a Neighbourhood association to move it forward. I would happy to advise on planting and management.

Report by Cllr D Wilson – Lytchett Minster & Upton Town Council

Cllr Wilson requested that residents should be reminded how to report issues to flytipping. This will be done via the Upton Link and Facebook.
