# 289/23 TO REVIEW ARRANGEMENTS FOR THE REMEMBRANCE SUNDAY PARADE 2022

#### Allotments:

The new 3 year management agreement between Upton and Lytchett Minster Allotment Association and the Town Council had been signed by both parties and would be operational from 1 February 2023.

#### **Recreation Ground and Pavilion**

The condition of The Grove and Pavilion remains a concern and a condition report was presented to the Town Council at its last meeting and a commitment to financial support was agreed. The Town Clerk had commenced dialogue with Dorset Council to utilise its framework of procurement. The high risk issues would be addressed first.

The issue with mole hills was becoming more evident. This issue had proved difficult to address in the past.

Funding had been put aside in the 2023/24 budget to resurface the car park.

A potential area to re-locate the skatepark was discussed. It was agreed to invite a play specialist consultant to the next meeting to discuss a way forward with the play area review, including the skatepark.
