318/23 TO CONSIDER ACTIONS TO MITIGATE THE CONSEQUENCES OF POLLUTION IN UPTON

Members held a detailed discussion about ways in which the Town Council can help to reduce the by working with its partners and local community. It was suggested that the local schools are included to share data and deliver a consistent message. To this end the Head Teachers of all three schools will be invited to the next Town Council meeting to discuss this.

Ideas discussed included a living wall, sustainable planting, car share, walking buses and information for householders on what plants they could install in their gardens to reduce the impact of pollution. The Outside Operations Manager would investigate feasible options for planting. A news item would be included in the next edition of Lyt-Up suggesting planting ideas to households which will help reduce the impact of pollution on the local environment.

It was also requested that an approach is made to BCP Council about the continued issue with the two Poole lifting bridges, which when closed, cause all the traffic to be routed through our town, causing increased pollution levels.

319/23 TO CONSIDER A REPORT REVIEWING THE TOWN'S PLANTING SCHEMES

Members approved a report recommending a move towards more sustainable flowerbeds in the town. This new planting schemes will require less watering and maintenance, and will provide a year-round display.

It was **PROPOSED**, **SECONDED** AND **RECOMMENDED** to change plant supplier for the forthcoming season.
