#### **Democratic Session**

Two members of the public attended to raise the issue of the Council's future plans with regard to skatepark replacement. They felt it was an important amenity, and whilst they accepted the Council's rationale to remove it, wanted to understand what plans the Council had to replace it. A discussion took place about potential sites, the importance of community consultation, financial restraints and timescales. Clarification was also given on CIL monies. They were able to offer some advice on surface materials, and future types, and advised they were willing to participate in supporting any future scheme. The residents felt that the skatepark site should be kept minimalistic in the future, due to its location.

## 94/23 DECLARATIONS OF INTEREST AND APOLOGIES FOR ABSENCE:

There were no declarations of interest and apologies for absence from Councillor Mrs K Austin (family commitments).

## 95/23 CLERKS REPORT:

- a) Minute 357/23 Remembrance 2023 Members were thanked for the feedback on the public statement, and this has been included accordingly. Further a summary statement has been prepared. The Town Clerk and Deputy Clerk will attend the DC Executive Meeting on 19 July where a representative from the SAG team will be present, so that the issues we have experienced regarding some of the information presented can be addressed directly. After this the TC statement will be shared with the RBL prior to being put in the public domain.
- b) Minute 43 /23/Warbler Park Play Area BCP have been instructed to remove the skatepark which will happen mid-July. A statement informing residents of this has been published and residents encouraged to provide feedback on how the site should be used. The feedback to date includes:
  - Safe and enclosed dog park / walking area;
  - Play ground or a fenced in football/basketball field. Kids have nowhere to play in this area.
  - Proper path required issues coming down the alley with pushchairs.
  - Whatever happens to the area it needs to be properly lit and maintained.

- I use the path on my journey to work. As a lady it doesn't feel safe and you can feel quite isolated. Needs to be more open, accessible and safe for everyone.
- We need something for all the teenagers in Upton.
- Put a park back there.
- A concrete skatepark (like Corfe Mullen) near the end of Upton rec where the gym part is.
- "I spoke to a representative from Aldi on the day the store opened and he told me that Aldi gave a money contribution to the council to upgrade the skatepark lighting and paths. Where has this money bene spent please? It is not supposed to be used to remove the facilities!"

All these matters will be considered after the skatepark has been removed, and a plan formulated with regard to the site.

The plan involves public consultation, grant applications and procuring a specialised contractor to lead the tendering process.

Members were presented with a report regarding the cemetery and future burial space. After consideration it was **PROPOSED**, **SECONDED** and **RECOMMENDED** to procure a land valuation for land opposite the cemetery. Further it was agreed to contact the Lees Estate to establish whether or not they have any land which might be suitable for future burial, as well as contacting Tappers and Cemetery Development Services with a view to ascertaining some likely costings for creating a new burial space. This information will assist the Council in forming a view of long-term burial provision for the Town.
