Upton Cemetery – Important Information

Upton Cemetery is a lawned cemetery encased by hedging and trees and is sited off the A350. It serves as an important amenity for the community of Lytchett Minster and Upton and beyond, and accommodates cremations and coffin burials. It has a small area for the burial of children.

There is parking available, and generally the cemetery is acknowledged to be well maintained and pleasant to visit.

A full set of Upton Cemetery guidelines are available on our website, and on request via our Help Centre.

It is important to note that there are certain times of the year when access to graves may be restricted due to surface water. These times can often be distressing for visiting families, and whilst the Town Council are sympathetic to this situation, there is a limit to what we are able to do practically to improve this situation, other than the significant measures we have already taken.

We feel it is important for anyone considering using Upton Cemetery to understand this. Whilst the Town Council has sought (as early as 2010) independent expert advice on remedies to reduce surface water, which it has followed and further enhanced, given the soil composition and the increase in average rainfall, these problems still exist when rainfall is sustained and heavy.

Increased ditch and French drain maintenance and clearance is scheduled throughout the year, and some ground has been left due to its unsuitability for burials. Regular jetting of the drain under Cemetery Road takes place, and on-going investigations and advice are taken to see what, if any improvements can be made.

Throughout all of the improvements and investigations, the Town Council members are briefed and updated. It is evident that this issue is not a Lytchett Minster and Upton Town Council Cemetery issue, but one which many burial authorities within the United Kingdom suffer from.

This information is given in an open and transparent manner in order to guide you to make informed decisions when thinking about using Upton Cemetery as the last resting place for your loved one.

Should you choose to entrust us with your loved one, you can be assured of our best efforts at all time in making Upton Cemetery a pleasant, calm and peaceful place.
