

## LYTCHETT MINSTER AND UPTON TOWN COUNCIL

## **Upton Cemetery Fees with effect from 1 April 2025**

The fees, payments and sums set out below apply when the person to be interred or in respect of whom the right was granted is, or immediately before his death was, an inhabitant of the town of Lytchett Minster and Upton, or in the case of a stillborn child, where the parents (or one of them) are, or at the time of the interment were, such residents; or where death occurs in a Nursing/Care home outside the parish and the person was a resident in the preceding twenty-four months.
