400/24 PUBLIC PARTICIPATION

401/24 DECLARATIONS OF INTEREST

403/24 CLERKS REPORT (PLANNING):

404/24 CORRESPONDENCE (PLANNING):

Members noted the potential breach of planning with several members having visited to see first hand the impact of the structure. Members were appraised that we had been advised the Planning had now visited the site and were passing this to Building Control.

405/24 UPATE ON NATIONAL PLANNING REFORM CHANGES:

Cllr Burns reported that nationally there are no major updates. However locally the impact of devolution and the formation of 'Wessex' to include Dorset, Wiltshire, Somerset and latterly BCP would change the planning landscape considerably. There is a deadline for January with regard to the consultation on this, however it is hoped that with a strategic high level authority Wessex could gear towards a rise in local decision making. 408/24 CLERKS REPORT

- a) Minute 171/22 Trailway Improvement Heritage Project:
 Cllr Griffin reported that sites and fixings have been identified and he is working on plaque information and letter to potential sponsors.
- b) Minute 316/23 Request for a crossing in Dorchester Road, Lytchett Minster: The location for a pedestrian crossing in the village does not meet Dorset Council thresholds and therefore will not be taken forward. The proposal to site a pedestrian refuge near the exit to Lytchett Minster School is still being drawn up and a site meeting will take place when this is ready.
- c) Minute 129/23 20 mph Speed Limit Sandy Lane and adjoining road. No further information.
- d) **Minute 269/23 Dorchester Road, Lytchett Minster Flooding**. The matter of Baker's Arms Flooding has been raised by our MP in Parliament. No other information to report on flooding in Lytchett Minster Village.
- e) Minute 150/24 To Discuss A Safer Routes To Lytchett Minster School, To Include Representatives From Lytchett Matravers Parish Council (Cllrs Morgan And Ong) No further information, but a suggestion that this should be linked to the pedestrian refuge proposal and a bid made to the Safer Schools Funding.
- f) 280/24 To Receive Report From Meeting Re Draft Local Transport Strategy For The Town Compiled By A Local Resident Independently Of The Town Council No response after submission of this report to Head of Highways at Dorset Council has been received.
- g) 341/25 BCP and UPC The relevant portfolio holder has been invited to meet with the Council to discuss matters of mutual interest and impact; however no response has yet been received.

410/24 TO CONSIDER AN APPLICATION TO DORSET COUNCIL FOR YELLOW LINES (TRO) AT WARBLER/HEIGHTS ROAD

Members voted 7 for, with 1 abstention to request Dorset Council to consider yellow lines (TRO) at the location as identified on the map (Appendix C). It was noted that there have been several accidents and many more near misses due to cars double parked in this area. It was agreed that the lay-by should not have TRO's.

IT WAS THEREFORE PROPOSED, SECONDED AND RECOMMENDED TO REQUEST DORSET COUNCIL FOR YELLOW LINES (TRO) AT WARBLER/HEIGHTS ROAD

411/24 TO DISCUSS THE ONGOING ISSUE OF DOG WASTE IN THE TOWN

Members are noting themselves of an increase in dog fouling, and complaints from the public have also risen. A meeting has been held with Dorset Council Waste Operations, particularly regarding the removal of the dog waste bin over the bridge onto Upton Heath. Whilst this was removed for operator health and safety in line with their operation regulations, the Town Council installed notices advising of the rational and informing where the nearest waste bin was, and also advising the dog waste could be taken home and placed in domestic waste bins. The problem still continues to Dorset Council are looking at this issue again, with perhaps a view to more permanent signage and/or increased enforcement.

The Town Council has requested additional visits from the Dog Warden on areas which have been identified as 'hot spots' – and it has been agreed to put up additional notices and highlight the penalties payable.

412/24 TO RECEIVE UPDATES FROM ENVIRONMENTAL CHAMPIONS

Lytchett Bay View Several washed up boats present on the shoreline, and a small

amount of litter. The new totems look good.

Street Furniture The Outside Ops Team have commenced a refurbishment programme

of seating using sustainable materials. Each bench will also have a unique reference and be plotted on a map for easier reference going

forward.
