490/24 PUBLIC PARTICIPATION

Samantha Dallimore from Wareham Arc Landscape Recovery Project was in attendance to provide a presentation.

There were no other members of the public present.

491/24 DECLARATIONS OF INTEREST

No Declarations of Interest were received.

492/24 APOLOGIES FOR ABSENCE

Apologies were received from Councillor C Squires and Councillor F Drane (non-business)

493/24 CLERKS REPORT (ENVIRONMENT):

- a) Minute 171/22 Heritage Project:
 - Cllr Griffin continues to work on this and is waiting for fact checking on data.
- b) Minute 316/23 Request for a crossing in Dorchester Road, Lytchett Minster: Dorset Council advise that the crossing location in Dorchester Road outside the former Post Office has failed to meet the threshold for a crossing. The pedestrian refuge proposal near to the school exit is still in design stages as the preferred plan for cyclists to cross Dorchester Road to safely cross the road.
 - It was reported that an on-site meeting with Dorset Council Principal Transport Officer took place on 25 March 25. Councillors Griffin and Wilson were in attendance as well as representatives from Lytchett Minster School and Lytchett Matravers Parish Council. The initial proposals were received positively. Particular comments raised with Dorset Council were as follows:
 - Extending the 30mph speed limit and remove the 40mph section.
 - Introducing a 20mph speed limit through the village.
 - Replicating the refuge as you approach the school exit from St Peter's Finger.
- c) Minute 129/23 20 mph Speed Limit Sandy Lane and adjoining road. Council have advised this request has moved forward to Stage 2 (Consultation) but have advised that this will be a lengthy process.

- d) **Minute 269/23 Dorchester Road, Lytchett Minster Flooding**. Cllr Wilson to provide any update as appropriate.
- e) Minute 150/24 To Discuss A Safer Routes To Lytchett Minster School, To Include Representatives From Lytchett Matravers Parish Council (Cllrs Morgan And Ong) It was reported that Cllr Wilson, the Town Clerk and Deputy Town Clerk attended a meeting recently regarding sustainable travel routes between Lytchett Matravers and Lytchett Minster. This was mainly around safety issues and safe access to Lytchett Minster School along Huntick Road. The meeting was led by Jack Wiltshire, Corporate Director for Highways, Engineering and Transport at Dorset Council. A suite of options were put forward by Dorset Council officers but many were not fiscally possible to implement. It was concluded that the most suitable option would be to further investigate a reduction in the speed limit along Huntick Road.
- f) Update on EV Chargepoints Dorset Council has advised the following: The site is awaiting connectivity.

494/24 CORRESPONDENCE (ENVIRONMENT):

Correspondence Environment: A) Email correspondence between the Town Council office and Dorset Council's Road Safety Team was shared regarding recent a road traffic collision along Dorchester Road. A motorist failed to stop at a red light to a pedestrian crossing and collided with 2 young pedestrians. One sustained a serious leg injury. The Town Council had been approached by an individual requesting that a 20mph speed limit is introduced to Dorchester Road. As advised by Dorset Council, a formal application would need to be made by the Town Council. Members were of the opinion that Dorchester Road did not warrant a 20mph speed limit and would not be recommending the pursuance of a formal application.

Members acknowledged the update on the planning enforcement matter from Dorset Council in respect of 92 Blandford Road North.

495/24 TO RECEIVE A PRESENTATION FROM SAMANTHA DALLIMORE FROM WAREHAM ARC LANDSCAPE RECOVERY

Samantha Dallimore provided an informative presentation on the local Landscape Recovery Project. This project is being led by Wareham Arc and is one of the first in the Landscape Recovery Scheme created by the Department of Environment, Food and Rural Affairs (DEFRA).

The project area is adjacent to Poole Harbour, North of the Isle of Purbeck and include Lytchett Minster and Upton. It covers 4000 hectares, with the objective being to create more resilient habitats through partnership working.

496/24 TO CONSIDER PROJECT PLAN TO UPGRADE LAND AT WARBLER CLOSE.

A project plan was presented which put forward proposals to revive the area of land at Warbler Close owned by the Council and previously occupied by the skatepark. It was anticipated that all the works would take approximately a month to complete and would be carried out by the Outside Operations Team and external contractors. Members were advised that the project had been budgeted for as part of the 25/26 Environment budget.

Members noted the report positively.

It was **PROPOSED**, **SECONDED** and

RESOLVED unanimously to accept the proposals to upgrade land at Warbler Close at an approximate cost of £12,530.

497/24 TO RECEIVE THE HIGHWAYS MEETING NOTES FROM 6 MARCH 2025

Members considered and noted the meeting notes. Particular discussion took place on the following matters:

- Watery Lane fly tipping. The option to closing this part of the highway to prevent fly tipping was not justifiable and unlikely to be supported by Dorset Council. Enquires would be made with Dorset Waste Services regarding the possibility in installing a fly tipping warning sign.
- Update on Traffic Regulation Order (yellow lines)
 Warbler/Heights Road. The Committee's recommendation for
 the implementation of yellow lines on this stretch of road was
 not endorsed by Full Council due to concerns that it would not
 solve the issue but simply relocate it. Alternative options were
 explored with Dorset Council's senior highways officer and
 following a site meeting, it was concluded that double yellow
 lines was the most suitable option. This would be re considered by the Committee in September.

502/24 TO RECEIVE AN OVERVIEW ON THE DAPTC / DORSET COUNCIL FUTURE PLANNING EVENT 4 MARCH 25.

Cllr Burns attended the above event which was arranged for Dorset town and parish councillors and officers. The salient points were:

- Changes to the National Planning Policy Framework:
 - Increased housing targets. Dorset's target has increased from 1,793 3,219 per year. This new target will need to be included in Dorset's Local Plan. These targets are mandatory and not advisory.
 - 5 year land supply will be based on the housing targets (Dorset has been 'fixed' until October 2025)
 - New concept of Grey Belt within Green Belt land.
 - Any development in Green Belt must meet the 'golden rules' including up to 50% affordable housing, infrastructure and local greenspace provision.
 - Duty to co-operate with neighbouring councils, such as BCP.
- New planning portal and online register.
