90/25 PUBLIC PARTICIPATION

There were no members of the public present.

91/25 DECLARATIONS OF INTEREST

No Declarations of Interest were received.

92/25 APOLOGIES FOR ABSENCE

No apologies were received.

93/25 CLERKS REPORT (ENVIRONMENT):

- a) **Minute 171/22 Heritage Project:**
These are in production..
- b) **Minute 316/23 Request for a crossing in Dorchester Road, Lytchett Minster:**
This is with Dorset Council and is progressing through their systems.
- c) **Minute 129/23 20 mph Speed Limit Sandy Lane and adjoining road.** Dorset will commence their consultation in October 2025.
- d) **Minute 269/23 Dorchester Road, Lytchett Minster Flooding.** Thanks has been sent to the Community Team in the East of the County to thank them for the clearance works that has been undertaken at the Bakers Arms Roundabout. It is hoped this work will increase the available capacity to hold water so that it delays it going onto the highway.
- e) **Minute 150/24 To Discuss A Safer Routes To Lytchett Minster School, To Include Representatives From Lytchett Matravers Parish Council (Cllrs Morgan And Ong).** An update has been received.
- f) **Update on EV Chargepoints – Dorset Council has advised the following:** These will be operational by the end of June.

- g) **Minute 496/24 To consider Project Plan to Upgrade Land at Warbler Close** The tree work on the Aldi side has been completed; however works to the former skatepark side were delayed due to a large wasps nests. Pest control were called to deal and the tree works will recommence shortly.
- h) **Cycleway Markings Update (Jun 25)** Dorset Council (CP) has checked to see if they can use Active Travel England funding, but that can only be used for rectifying minor issues – i.e. dropped kerbs or small changes to infrastructure, not the maintenance of existing assets. Other cycle markings Dorchester Road, Upton to bridge over bypass – no budget for this maintenance – but Dorset Council's asset team have invited the CHM to send a 'client brief' to outline the need and why – there is no timescale for these to be done, but it will be put on the list.
- i) **Updates to requested TRO** - Old Kiln Road and Heights/Douglas TRO are currently sitting at numbers 5 and 6 on the list – advised legal process will commence early 2026.
- j) **Pinewood Road** – micro-surfacing will be undertaken 2025/26 financial year – no specific dates given.
- k) **Watery Lane, LM** No resurfacing plans currently.

Members noted the Phase 3 update from Dorset Council, that formal TRO public consultation on the scheme put forward in October 2025.

Members noted the contents of the May 2025 update from the Implementation Team Manager at Dorset Council and voiced the continued need for partnership working with Lytchett Matravers Parish Council on matters of shared interest .

103/25 TO CONSIDER PLANNING APPLICATIONS:


The observations on the planning applications discussed at the meeting are set out on the attached list (June 2025) as Appendix B.
