Minutes of the **ENPLAN** meeting held on **TUESDAY** the **19 August 2025** in the Council Chamber, 1 Moorland Parade, Moorland Way at 6.30 p.m.

153/25 PUBLIC PARTICIPATION

There were 8 members of the public present and were welcomed by the Chair of Planning. Each present were given the opportunity to speak. The following points were raised:

Ref: Planning Application P/FUL/2025/03164 Change of use of land (to provide 14 residential caravan pitches, each consisting of 1 static caravan, 1 touring caravan, day room, parking, bike and refuse storge, EV & EC charging and associated works including soft and hard landscaping and fencing for Gypsy & Traveller Families.) Land adjacent to Slepe Park Dorchester Road Lytchett Minster BH16 6HT

A number of the members of the public present raised their concerns relating to the above planning application, as follows:

- a. Proposal not in keeping with nearby properties (Grade II listed cottage). Impact on heritage.
- b. Road safety site access/exit from A35. Known accident blackspot. Particularly difficult for large vehicles and caravans.
- c. Drainage issues.
- d. Land has always been green land and a natural habitat until the recent hard standings were constructed.
- e. Planning application fails to refer to:
 - Biodiversity impacts.
 - Tree ownership and TPO on Oak Tree located on the land.
 - Transport links.
- f. Proximity of existing mobile home units is very close lack of privacy.
- g. The 14 pitches could potentially accommodate up to 112 people on the site.
- h. Environmental impact excess spillage transferred to Poole Harbour via streams on the farmland.
- i. Potential 30 hectares of sewerage discharge.

All members of the public present were thanked for their comments and encouraged to refer their concerns formally to Dorset Council. Those present were informed that this was likely to be referred to Dorset Council's Planning Committee which members of the public are entitled to attend.

2. A resident raised their concerns relating to a neighbour's recent installation of a 6ft fence in front and to the side of the property. Members were shown photos. The resident was advised that this should be referred to Dorset Council's Planning Enforcement Team to investigate and conclude whether it contravenes planning

requirements. The resident advised that another neighbour had been in contact with Dorset Council.

154/25 TO RECEIVE A PRESENTATION FROM LAURA GOWERS, WESSEX WATER ON THE TOWN WATERMARK AWARD

Laura Gowers, Community Outreach Co-ordinator at Wessex Water provided an overview of this civic award.

To gain Watermark Town status, the town would need to commit to the promotion of the 'Raising Awareness' activities and commit to at least three 'Taking Action' activities over at least a 12-month period.

This will likely require some local officer time to support, however, Wessex Water would commit to supporting these local campaigns over the initial 12 months.

Support available includes:

- local data and information
- 'Watermark Town' marketing materials bespoke to your local area
- ready-to-go social media content
- funding up to £5,000 for local projects and events for the local community.

Members thanked Ms Gowers for attending and would consider the Council's involvement in the scheme at a future meeting.

158/25 CORRESPONDENCE (ENVIRONMENT).

159/25 TO CONSIDER DRAFT COMMUNITY RESILIENCE PLAN AND WINTER MAINTENANCE PLAN

Members received and considered the above plans. Although the Town Council does not have many statutory responsibilities for the emergency scenarios referred to in the plan, it had an important role in disseminating information to residents to educate them on how to prepare for, avoid and manage these scenarios.

It was agreed to include heath fire in the risk assessment.

RECOMMENDED unanimously to approve the Community Resilience Plan and Winter Maintenance Plan.

160/25 TO RECEIVE UPDATES FROM ENVIRONMENT CHAMPIONS

Lytchett Bay View The Outside Operation Team had replaced the Perspex cover of the

interpretation board at the entrance to the view point.

It was reported that the dog waste bin needed emptying.

Upton Woods It was reported that the flow of the stream was slow. This was likely to

be due to the low water levels.

161/25 TO RECEIVE FINANCIAL REPORTS FOR ENVIRONMENT

The financial report up to 31 July 2025 was considered. Members were advised that as of this date, 19.7% of the allocated budgets for the committee had been spent. However, a number of key projects had yet to be completed such as the Warbler Close land refurbishments and the Heritage Plaques.

162/25 CLERK'S REPORT (PLANNING)

There was no Clerk's Report for planning matters.

163/25 CORRESPONDENCE (PLANNING)

An email was considered from a local resident in response to Planning Application P/FUL/2025/03164 (Change of use of land (to provide 14 residential caravan pitches, each consisting of 1 static caravan, 1 touring caravan, day room, parking, bike and refuse storge, EV & EC charging and associated works including soft and hard landscaping and fencing for Gypsy & Traveller Families.) Land adjacent to Slepe Park Dorchester Road Lytchett Minster BH16 6HT).

The email highlighted concerns over the number of residential mobile homes sites built within a one mile radius of the Lytchett Minster and Upton Parish. The resident estimate there to be at least 700 mobile homes. Members agreed to consider this in greater details at the next meeting of the committee.

164/25 UPDATE ON LOCAL AND NATIONAL PLANNING REFORM CHANGES

Members noted that Dorset Council had published its draft Local Plan and commenced the consultation exercise the day prior to the meeting (18 August). As the plan and its supporting documents were significantly lengthy and detailed, it was agreed that the next ENPLAN meeting would be dedicated to the document and the Council's response. It was noted that although the draft document referred to proposed figures to housing allocations, it would have a significant impact on the town.

165/25 DORSET COUNCIL PLANNING DECISIONS:

A list of Dorset Council planning decisions was circulated to members for information, and is attached to these minutes for reference as Appendix A.

166/25 TO CONSIDER PLANNING AND TREE APPLICATIONS:

The observations on the planning applications discussed at the meeting are set out on the attached list (August 2025) as Appendix B.

167/25 ITEMS OF REPORT (INCLUDING PUBLICITY OPPORTUNITIES) AND MATTERS FOR FUTURE AGENDAS.

- A document on potential devolved services the Town Council could take on was being drafted by the Town Clerk and would be presented at the next Finance & Administration meeting.
- 2. Members were advised that the speed limit along Upton Road (BCP) had been reduced from 60mph to 30mph.
- 3. The Council had received a significant number of complaints regarding a white van parked along Poole Road. The Council has been in regular contact with Dorset Police and Dorset Highways who have carried out site visits. The conclusions is that, despite the inappropriate position of the van, it is not parked illegally and therefore there is no means in which to enforce its removal. The Police have been asked to have a polite discussion with the owner to move the van to a more appropriate position.
